GOVERNMENT RELATIONS & ADVOCACY UPDATE

Congressional Retirements Promise to Make Waves

As the 2018 midterms approach, a growing list of senators and representatives have announced their intentions not to run for re-election. Altogether, the number of U.S. lawmakers vacating their seats in 2018 has reached 51. While some of these individuals will be seeking a new office, a surprising number have opted to retire from public office outright.

The Senate and House are losing a number of long-serving members whose institutional guidance and leadership will be sorely missed as Congress attempts to extract itself from the malaise it currently finds itself in.

Twenty-four of these retirements and resignations reside within the Republican caucus, a historically high number, which rivals the number of retirements experienced during the Nixon and Bush presidencies, according to a FiveThirtyEight analysis. What is most striking about these numbers, however, is their distinctly partisan distribution. Only eight Democrats have vacated their positions outright heading into 2018.

Observers have speculated that frustration over a dearth of legislative achievements has spurred the wave of retirements. Others see a controversial president and the looming prospect of bitter re-election battles as the predominant cause. The truth most likely lies somewhere in between, combined with a dose of exasperation over the White House's seemingly mercurial disposition.

No matter the most accurate interpretation of the current spate of retirements, the volume of vacancies promises to alter the

political calculus in Washington. Despite the persistence of anti-establishment backlash among U.S. voters, incumbents continue to enjoy substantial performance advantages year over year. Combined with midterm elections that are historically unfavorable to the governing party, the wave of open seats bodes poorly for a Republican majority that is already operating on razor thin margins.

Within this environment, House Speaker Paul Ryan (R-WI) has expressed wishes to move ahead with major entitlement reforms. Reform of Medicare and Medicaid in particular has been one of Ryan's longstanding goals, with funding cuts a nearly certain feature of his ambitions.

The chances of any entitlement reforms originating in the House passing the muster of the Senate, however, seem slim. With a margin that has shrunk even further in the wake of Democrat Doug Jones' Senate election in Alabama, McConnell has signaled that any such effort would be doomed to fail.

Governor Makes Appointments to GME Board

Governor Eric Holcomb announced several appointments and reappointments to various state commissions and boards, including the Graduate Medical Education Board. Dr. Paul R. Haut (Carmel), COO of Riley Hospital for Children, will continue his service on the board. His term expires December 31, 2019. Dr. Tricia L. Hern (Zionsville), vice president of academic affairs for Community Health Network. Her term expires December 31, 2019. Timothy Putnam (Batesville), president and CEO of Margaret Mary Health. His term expires December 31, 2019. Dr. Jeffrey Rothenberg (Indianapolis), chief medical officer at St. Vincent Hospital. His term expires December 31, 2019. Beth Wrobel (Valparaiso), CEO of HealthLinc, will continue her service on the board. Her term expires December 31, 2019. Dr. Rachel A. Shockley (Indianapolis), program director for Community Health Network Family Medicine Residency South, will join the board. Her term expires December 31, 2019. (Inside INdiana Business)

Medicaid Drops Thousands for Not Paying Premiums

About 25,000 adults were kicked off the Healthy Indiana rolls, between its start in 2015 and October 2017, for failure to pay their premiums, according to state reports. Yet state officials estimate, based on surveys of recipients, that about half of those people found another source of coverage, most often through a job. During the first two years of the experiment, about 10,000 Indiana Medicaid enrollees were subject to the six-month lockout for failing to pay the premium for two months in a row. Several Republican-controlled states that expanded Medicaid have followed Indiana to adopt premiums. And the Indiana model is also attracting attention from some of the 19 conservative states that are leery of expanding Medicaid. (Kaiser Health News)
